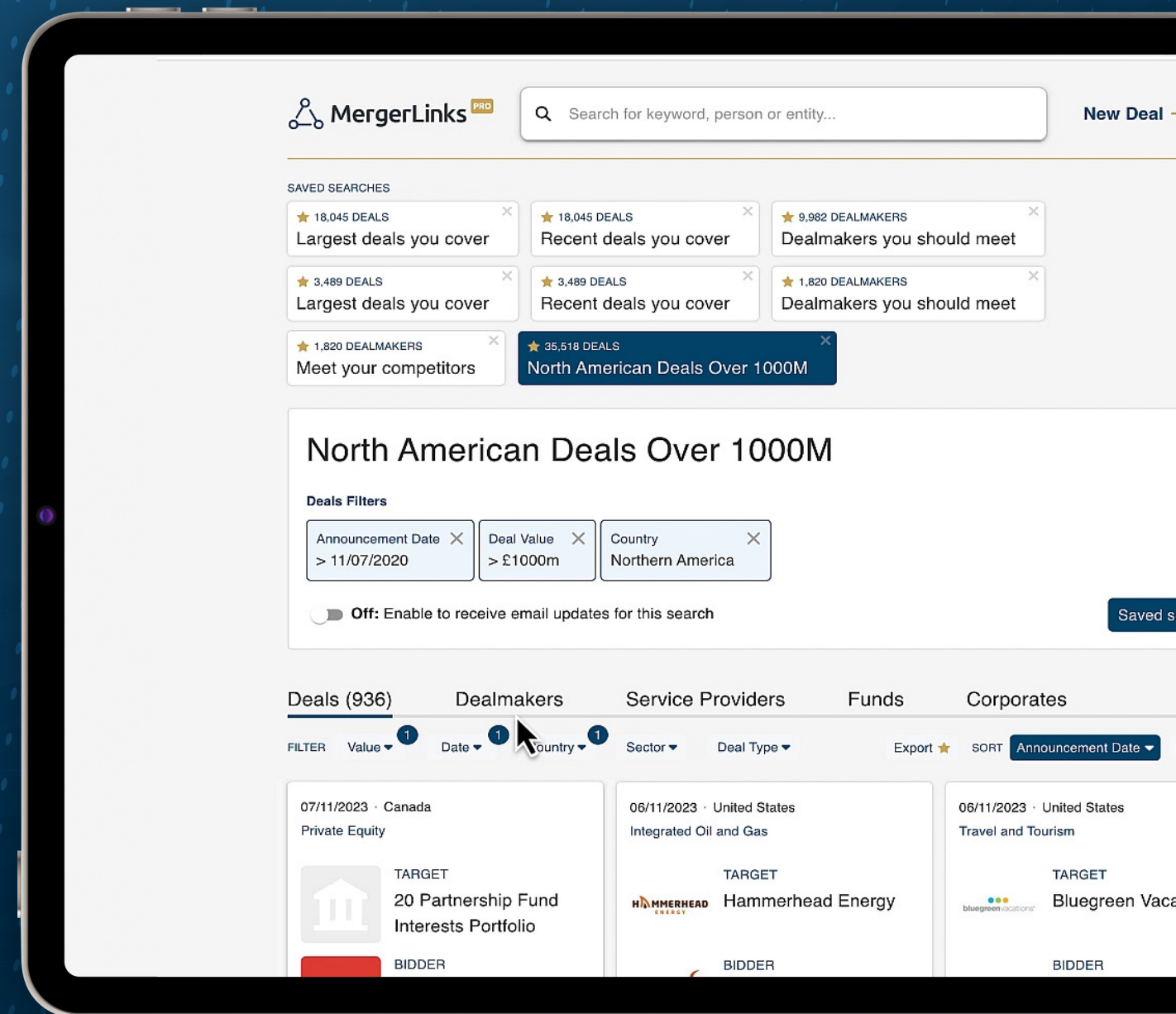

# Methodology

## LEAGUE TABLES

The league tables are based upon either cumulative deal value (GBPm) or the number of transactions in a specified period. Cumulative transaction values and volumes are based off the announcement date.

Any non-GBP deal values will be converted as at the date of the transaction announcement. When the deal value of the eligible transactions is not disclosed advisors receive volume credit. Only deals with a deal value of GBP100m or more are taken into consideration. If deal value has not been officially disclosed, revenue or asset thresholds can be used to determine qualifying deals.

MergerLinks' league tables include dealmakers leading the transaction. Leadership is defined based on the publicly available documents or the advisor's submission with regard to its own team. Each league table specifies a strict timeframe, geography, sector, deal type, deal value, firm roles, and specialties for which the ranking is compiled. Specialist tables consider individuals with a professional focus on a particular aspect of transactions.
